



PARENT, PLAYER, & COACH CONTRACT

PARENTS:

1. Parents are expected to make sure that their child is at all practices and games on time and picked up in the same manner.
2. Parents are expected to conduct themselves in a sportsman like and respectful manner at all times. No harassment of coaches, players, or umpires will be accepted at any time.
3. Parents are responsible for the necessary travel arrangements, and when needed, providing for room and board for their child for out-of-town games.
4. Parents should understand that the baseball team competes in tournaments that are extremely competitive and therefore guaranteed or equal playing time is not an expectation. The head coach will be dedicated to the development of each players skill set and will strive to give all players the opportunity to display those skills in game situations.
5. Parents are expected to place the success of the team ahead of the success of the individual.
6. Parents understand that fees are to be paid on time. The commitment begins the day of tryouts. If payment arrangements are necessary, you must present your needs to and have it approved by the team officers.
7. Parents are expected to address the coaching staff in a positive and cooperative manner about ideas, suggestions or problems that they wish to discuss. If a conflict does arise, the Greeley Grays Youth Baseball program has a 24 Hour cool down period prior to discussing the issue with the coaches. Parents will wait until emotions have subsided before contacting the head coach for the team. All concerns and issues should be directed to the head coach; who, if appropriate, will bring the concern or issue to the attention for the board.
8. Parents are to discuss concerns pertaining to their own child and no other players.
9. Parents will not coach their player or any other player while in the stands.
10. Parents will not have discussions with coaches pertaining to ANY coaching decisions.
11. Any violation of the above mentioned will result in one oral and written warning. A subsequent violation will result in your child being released from the program.

PLAYERS:

1. Players are expected to be at all practices and games on time and ready to play. The only allowed excuse is one discussed with the coaching staff prior to the scheduled event. If you do miss, it is your responsibility to find out what information you missed.
2. Players are expected to conduct themselves in a sportsman like manner at all times. Disrespectful actions to opposing team players, coaches, or umpires are not acceptable. Remember, your actions reflect not only on you, but also on the entire Greeley Grays organization.
3. All players are part of the team and in that light will provide positive support for others on the team. Harassment and disrespectful actions of others will not be tolerated.
4. Players are expected to notify the coaching staff of any physical or personal problems that may affect their performance prior to the scheduled event.
5. Players are not allowed to use tobacco, alcohol, or drugs in any form.
6. Players are expected to give 100% effort at practice and games.
7. Any violations of the above may result in single/multiple game suspension or expulsion from the program. All penalties will be reviewed by the coaching staff.

COACHES:

1. Coaches will play players that have the demonstrated skills needed to play in a competitive environment.
2. Coaches are expected to provide the highest level of coaching skills that they are capable of at all times, and lead by example.
3. Coaches are expected to adhere to the Coaches Code of Conduct set forth by the Organization.
4. Coaches will not have discussions with parents about other players.
